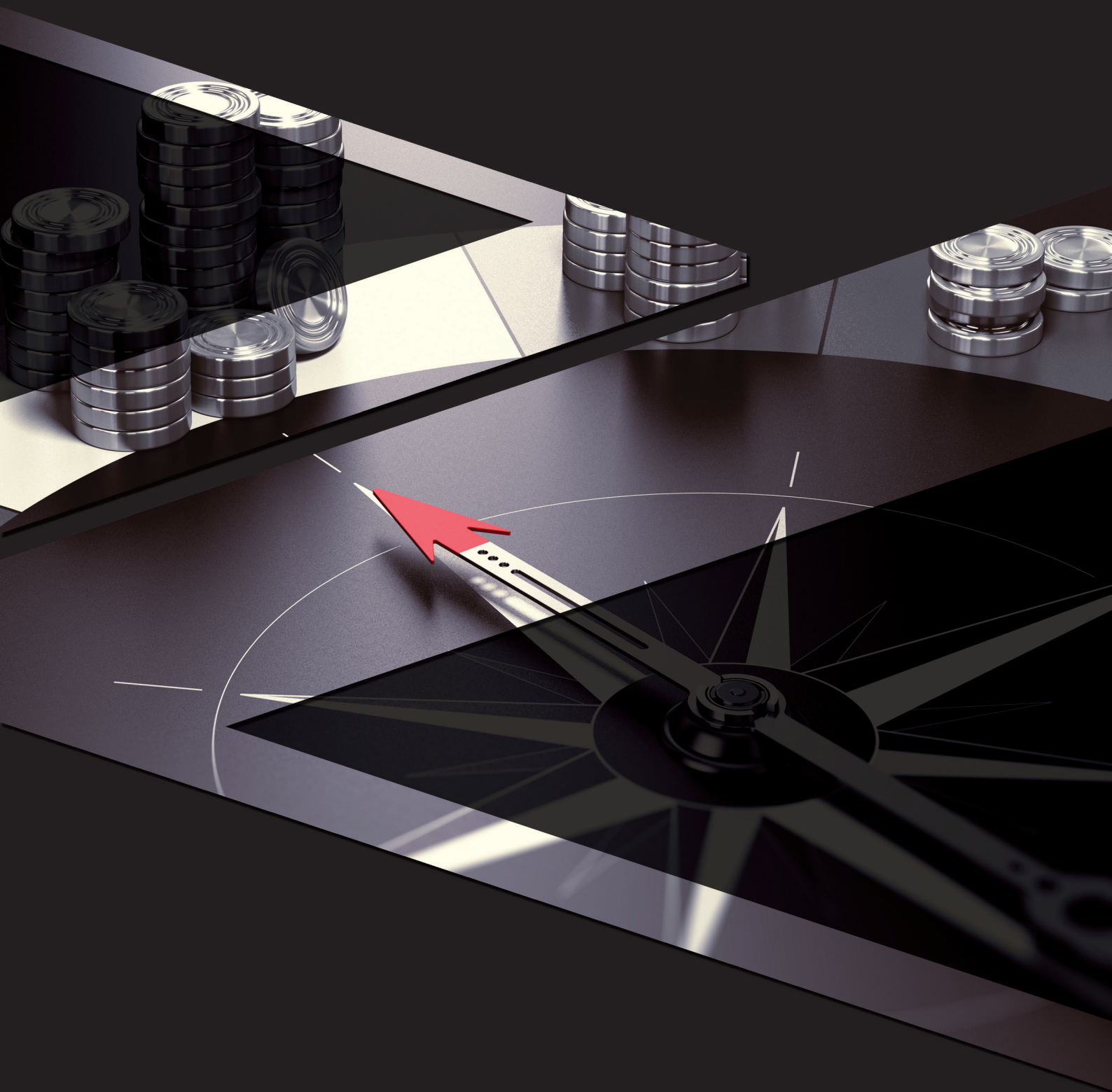

The Financial Services Commission (FSC) established in 2001, has signed several Memoranda of Understanding (MoUs) with local, regional and international counterparts aimed at:

- Consolidating supervision of cross-border operations of financial institutions
- Defining mechanisms to share information in accordance with international standards
- Re-enforcing collaboration among institutions in the fight against crime, Money Laundering and Financing of Terrorism
- The FSC is also committed to adhering to international best practices on transparency and disclosure of information
